In this office circular second cited, the Principals of all Engineering colleges were informed about the preliminary guidelines for admission to PG degree courses for the year 2012-2013. Further guidelines for admission to MBA / MCA degree courses for the year 2012-2013 are given below based on the recommendations of the Tamil Nadu MBA / MCA Co-ordination Committee constituted by the Government vide G.O. third cited.

- 1) Qualifying Examination and Eligibility
  - a) **MBA**

A pass in any recognized Bachelor's Degree (in any discipline) of minimum 3 years duration and obtained at least 50% (45% in case of candidates belonging to reserved categories) at the qualifying examination with

- i) 10 + 2 + 3 years pattern (or)
- ii) 10 + 3 years Diploma + 3 years pattern (or)
- iii) B.E / B.Tech / B.Arch / B.Pharm (or)
- iv) AMIE with 2 years regular full time Teaching experience / Industrial experience in the relevant field after passing all the subjects.

Reserved categories : BC, BCM, MBC / DNC, SCA,SC and ST

b) **MCA**

A pass in any recognized Bachelor's Degree (in any discipline) of minimum 3 years duration and obtained at least 50% (45% in case of candidates belonging to reserved categories) at the qualifying examination with

- i) 10+2+3 / 4 years pattern with Mathematics\* at Plus Two level (or)
- ii) 10 + 3 years Diploma + 3 years pattern with Mathematics\* at Diploma level

Reserved categories : BC, BCM, MBC / DNC, SCA,SC and ST

\* Business Mathematics will not be considered

c) **Other norms:**

- i) Candidates who have obtained B.E through Lateral Entry or Part Time B.E after Diploma through Lateral Entry (after qualifying 10+2) or after Part Time Diploma are also considered eligible.
- ii) Candidates admitted through Lateral entry in Degree courses are not eligible except B.E / B.Tech degree courses.
- iii) Candidates with B.E / B.Tech / MCA / M.Sc degrees obtained through Week end courses and B.E / B.Tech through Distance mode are not eligible
- iv) Candidates who have not studied 10<sup>th</sup>, Plus Two / Diploma as prescribed are not eligible
- v) The qualifying UG Degree awarded by Universities should conform to the minimum standards of instruction for grant of the First Degree through Formal / Non Formal / Distance (wherever applicable) Education prescribed by UGC

d) **Computation of Minimum Eligibility Marks in the qualifying examination**

- i) In order to maintain uniformity in computation of minimum eligibility marks at qualifying degree level, the average % of marks obtained by the candidates in the entire duration of the qualifying UG degree (semester / yearly pattern) course should be considered.
- ii) Rounding off of minimum eligibility marks is not permitted.

e) **Migration from one University to another**

i) Candidates who have migrated from one University to another during their UG course of study can be considered for admission subject to the following conditions :

- i) Fulfillment of eligibility norms prescribed
- ii) Candidates continues the same course / relevant semester or year under the migrated University and finally awarded degree by the migrated University

ii) Candidates who have discontinued the course under one University and later on continue the remaining duration of the study under the migrated University cannot be considered as eligible.

f) **Dual mode of study**

Candidates who have pursued 10+2 / Diploma parallelly with qualifying degree under Dual mode are not eligible.

Candidates should have undergone 10<sup>th</sup>, +2/Diploma and Qualifying Degree in sequence as mentioned under (a) and (b) above

g) **Entrance Examination**

i) Candidates admitted under Government quota should have written the TANCET 2012 examination

ii) Candidates admitted against seats retained by the Managements should have written the Entrance examination prescribed by the Committee to monitor / regulate admissions to Self Financing Professional, Arts and Science colleges.

g) **Admission to M.E / M.Tech / M.Arch / M.Plan courses for the year 2012-13**

Already Principals have been informed in this office circular second cited that the eligibility norms / qualification to PG degree courses for the year 2012-13 as prescribed by TANCET Co-ordination committee has been hosted in the DOTE website. h) **Admission to M.E / M.Tech Degree courses under Day time Part Time Mode**

As per the resolution of the Syndicate of Anna University, Chennai-25 communicated in Letter No. R/PG.Admn/2003 dated : 3.6.2003, the following norms are to be adopted for admission to M.E / M.Tech Degree programmes under Day time-Part time mode. Candidates admitted under this mode of study should fulfill the following conditions :

- i. Should be a Teaching staff working in the affiliated college of Anna University.
- ii. Should be working in the same college or a neighbouring college situated within a radius of 25 Kms from the college of study
- iii. Should have minimum one year teaching experience
- iv. Should fulfill eligibility requirements for admission to M.E / M.Tech degree courses as prescribed by TANCET / TANCA Co-ordination Committee
- v. Should be admitted within the AICTE sanctioned strength or over and above upto 10% depending upon the necessity

i) **Equivalence**

Any discrepancy in the eligibility of the candidate (qualification, period of study, mode of study etc.) admitted to PG degree courses will be referred to the TANCET Co-ordination committee and the decision of the TANCET Co-ordination committee will be final. The equivalence issued by any other authority (like concerned University etc.) will not be accepted.

j) **Recognized University**

Principals are requested to ensure that the student has qualified from a University recognized by UGC. The definition of “University” as found in UGC Act 1956 is given below :

“University” means a University established or incorporated by or under a Central Act, a Provincial Act or a State Act, and includes any such institution as may, in consultation with the University concerned, be recognized by the Commission in

accordance with the regulations made in this behalf under this Act.
